This is however, subject to compliance with the relevant rules, regulations & norms notified by the University related to admissions.

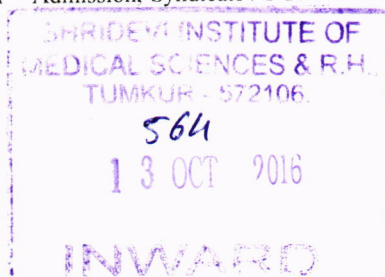
